A utility bill credit is available to encourage **GP&L Commercial Customers** to install high efficient lighting. Please direct any questions to **972-205-2929** or email energyadvisor@gpltxas.org or visit www.gpltxas.org for complete details. **Program starts October 1, 2017 and ends on September 30, 2018 or once funds are depleted, whichever comes first. (No credits will be issued for installations that occurred before October 1, 2017). Program may be discontinued or modified by GP&L at any time.** The number of rebates in a fiscal year is not guaranteed, nor the availability of funds for a credit. Please call 972-205-2929 to make sure the program is still available before purchasing equipment.

- A commercial customer must call 972-205-2929 for a lighting survey of **existing** facilities.
- A signed GPL Lighting Credit Application form must be submitted and a pre-site survey completed in order to receive project approval. Upon approval, lighting retrofit may begin. Once retrofit is complete a post-site survey is required. Replacement/installation and count of lamps and ballasts will then be confirmed and eligible credit will be determined.
- No credit shall be given until retrofit is 100% complete & customer has submitted credit request and all **(3) ITEMS BELOW.**
- Ballast & fixture replacement must be performed by a licensed contractor. All applicable state or city codes must be followed.
- All lighting retrofit projects require a pre-inspection prior to work being started. **The fixtures being retrofitted must be energized and in operation.** A final inspection of all qualifying equipment will be conducted once the site is accessible. The customer, contractor, responsible agent or owner is responsible for scheduling this on-site inspection.
- **Final disposal of old lamps will be the responsibility of the contractor in accordance with local solid waste regulations and disposal of all old ballasts will be in accordance with EPA and TCEQ regulations**
- The credit is based on kW demand reduction. **(\$100 per kW Reduced - 200 kW Maximum / \$20,000 Maximum Credit)**
